He began work in the Sheriff Clerk's office in Wick in 1879. In 1884 he was appointed Sheriff Clerk Depute at the age of 20, retiring in 1931. Whilst in office he had a range of other roles and businesses. He was a fishcurer, insurance agent, landlord, Secretary of the John o' Groat Steam Laundry and owner of the steam drifter 'Zoe' and motorboat 'Fruitful'

> Rugg served with the Caithness Artillery Volunteers, retiring with the rank of Major. He was awarded the

M.B.E. in 1932.

The family lived at Moss Palm, Sinclair

Terrace, Wick.

In 1921 the Ruggs took over the rental of Invercharron Mains Farm, Ardgay, Ross- shire, where they moved in 1931 after Andrew Rugg's retirement.
