General Henry Sinclair Horne, 1st Baron Horne of Stirkoke, GCB, KCMG (19 February 1861-14 August 1929) was a military officer in the British Army, most notable for his generalship during the First World War. He was the only British artillery officer to command an army in

the war.

Stirkoke House

Stirkoke House, the family home of the Horne's, was badly damaged by fire in the early 1960's. As the family lived mainly in England by that time the house was never repaired but left to decay. What contents were salvaged after the fire were stored in outbuildings awaiting disposal by auction sale. The items did not make sale and were to be destroyed when a gentleman asked to have them. Amongst other items the items saved contained General Horne militaria and papers from the business of Alexander Gunn, Auctioneer in Wick. The papers

passed through other ownership until finally arriving with Andrew Guttridge who recognised the significance of

preserving the contents.
