Name of creators: Harold B. Reid

Administrative history: Harold Reid was a well-known name in Wick as

many inhabitants visited his chemist shop in the

High Street in Wick.

Harold Buchan Reid, originally from

Invergordon, came to Wick shortly after the first World War and took over the chemist shop in Wick, High Street, in around 1924 from his brother Willaim George Reid. He operated the shop for 20 years before his sudden passing in

1944.

The Chemist was then managed by his wife Isabella Jane (nee Budge) until their only child

Harold Campbell became qualified.

Harold's sporting interests included being a regular player for the John O'Groats F.C. in his early years. When his playing days were over he continued to take a keen interest in the club

and its welfare.

Harold was also a keen golfer and member of Wick Golf Club. This interest was passed on to his son Harold Campbell who was a regular golfer. The Wick Senior Golfers at Reiss Golf Club now regularly compete for a trophy

bearing Harold's name.

Harold's other interests extended into the arts and he was a member of the Wick Operatic Society and Wick Players, being responsible for

the make-up of the casts.

Harold in later years became an officer in the Wick Sea Cadet Corps, with the Sea Cadets

providing an escort to the funeral hearse upon his passing.
Harold Campbell featured in a recording by Wick Voices where he speaks about his childhood during World War II and running from machine gun fire.
